Where did our steps, lanes, and raises come from last year?

This is a great question because it illustrates an important source of CSEA's and CEA's power and effectiveness – the ability of our organization to influence and craft legislation that helps you in your classroom and with your family. This is made possible by the small contribution to political activities that we ask of members. Specifically, last year, the most important reason CSEA was able to negotiate a raise and unfreeze steps and lanes was a law called the Student Success Act. We, in collaboration with CASE and CASB, were able to work with state legislators and the Governor to reduce the “negative factor” by \$110 million. Thus, CSEA's political engagement benefitted our members with thousands of dollars in recurring compensation. That is one example of a remarkable return on investment!
