CSEA is allotted eight delegates to the NEA Representative Assembly. The President, Joe Schott, is automatically a delegate according to the CSEA Bylaws. There were four nominations, and therefore, the following candidates are declared elected: Adrienne Hause, Sarah Jacobs, Leigh Slimp-Virgo, and Kevin Vick.

At the March 10, the Association Representatives voted to bring proposed Amendments to the CSEA Bylaws to a vote of the membership. That election will take place April 2-9.
