### Professional Autonomy Provided By The Master Agreement

Today we hear from James Divine (Swigert), on how he appreciates the professional autonomy provided by our collectively bargained Master Agreement and how his principal appreciates the professionalism we promote:

I'm in my second year in D-11. I feel like I have been given a lot of professional autonomy to decide how best to teach band and orchestra - especially during this time when we had to shift to online learning. My rater treats me as a professional. I feel he is working WITH ME on the teacher evaluation to both help me do well on the evaluation and help me to be a better teacher. I leave his office feeling great about myself as a teacher. At my prior district, I was not covered by a Master Agreement. I had some professional autonomy, but not as much as in D11.

An example of the professional autonomy this member so values is set forth in the Master Agreement (Article XI. B):

#### B. Academic Freedom

1. The appropriate exercise of academic freedom is essential to the fulfillment of the purposes of the District . . . Teachers are assured of the support of the District when the actions of the teacher are in accord with the law and the terms and provisions of this Agreement. Furthermore, no teacher will be subject to disciplinary action for discussing controversial issues when his/her conduct is the result of professional judgment by the teacher, in accordance with District policy and regulation.

It is important to remember that the legislature still needs to cut more than \$3 billion from the state budget and this money *does not* help provide any relief to that process. **Locally**, this newest money should provide around \$13 million targeted specifically to addressing costs incurred by COVID. That could be a bright spot in Master Agreement
