Bargaining

Bargaining continues June 1-4, when CSEA and D11 work through financials. The State budget is not complete as of today, but Federal funding has been coming in to soften some of the cuts, but until we have firm numbers, there are no decisions. The Board of Education's public discussions (i.e. recorded meetings) on their priorities are available on their website, an example of which is found [here](#). As noted, the next bargaining session is June 1. Contact [CSEA](#) if you would like more information about it. Assuming we reach a tentative agreement, following a 24-hour embargo on releasing information, it will be presented to the CSEA Board of Directors for a vote on whether to recommend the agreement to the membership and then dissemination of info to the membership. A ratification vote will then be scheduled--a very short turn-around time. **Be sure to check your D11 email after June 5 for information on and voting instructions.**

Dear Members,

Now is a very important time for member engagement. In this time of constant changes and uncertainty bargaining is ongoing. We have made significant gains for teachers' rights, but the team has delayed talks for financials until the first of June. We are waiting for the state legislature to pass the budget, and news from the state is fluid, making our work in bargaining impossible at this point. Because of these delays, the ratification of the agreement will be postponed until we are done with the entire package. Unfortunately, that means that voting on ratification of the agreement will take place after the school year has been complete. Because of this delay we need you to continue to be

engaged by reading your emails frequently. Since we are not in school our person to person contact that CSEA relies on is impossible. We cannot stress enough how important it is that all members watch out for emails communicating the results of bargaining and the ratification of the agreement.
